I understand that my obligation is to pay the tuition for the full academic year of 2022-2023 and no portion of such tuition, paid or outstanding, will be refunded or canceled, notwithstanding the subsequent absence, withdrawal or dismissal of the above named student from Saint Mary's Catholic School. The Saint Mary's School Finance Committee may consider a release from the obligation to pay tuition for the full academic year upon a physician's certificate of the necessity for withdrawal of the student for health reasons, or upon permanent relocation of the entire family from the area. Other reasons, such as financial hardship, for release from this obligation to pay tuition for the full academic year may be considered by the Finance Committee upon written request by the parent/guardian. All decisions for the release from the obligation to pay the full year's tuition shall be made only at the sole discretion of the Saint Mary's School Finance Committee.

It is further agreed that enrollment, as specified within this Enrollment Contract, may be canceled by me in writing prior to July 1, 2022 without further obligation except forfeiture of the \$275/\$375 registration fee.

I also agree that my relationship with the school shall be governed by this agreement and the rules and regulations as stated in the school’s Parent and Student Handbook, a copy of which is available in the school’s office and online. I acknowledge and understand the school’s policy concerning payment of tuition, and I agree that any action related in any manner to the enforcement of this agreement shall be litigated in the Superior Court of Floyd County, Georgia, and I hereby waive any defense of lack of personal jurisdiction and venue which may exist now or hereafter. This instrument shall be interpreted in accordance with the laws of the State of Georgia.

I also understand that as an ordinary and usual part of its educational policies and business, Saint Mary’s Catholic School may prepare and produce certain promotional materials, advertising, newsletters, yearbooks and other publications, and I hereby give my permission for photographs of the named student to appear and be used in such matters, and waive any and all claims which may arise out of such appearance or use, and hereby release and discharge Saint Mary’s from any and all such claims.

I fully understand that in order to reserve a place for the above named student, the school must receive this signed Enrollment Contract by **April 30, 2022** or, for new students, within two weeks of notification of acceptance.

Registration fees must be paid in full in order for the student(s) to be considered enrolled for the school year.
